



Getting there - Directions!

Camden County Courthouse: Take 676 north to Mickle Blvd. Flow right at the fork (don't go on Campbell Place), then turn right onto 5th street in a few blocks. The courthouse is at 5th and Federal, a block up from Mickle.

Camden, Federal Courthouse: 4th and Cooper, but we generally car pool. Call 856-795-7878 if you're interested. *About 3-4 blocks from the City Hall PATCO station.*

Cherry Hill Library: On King's Highway, coming from Haddonfield, cross Route 70. The library is a half mile or so ahead, on your left. Before Chapel Ave.

Lindenwold High School: 801 Egg Harbor Rd. Take Route 30 (WHP) south past the Echelon Mall area to Gibbsboro Road. Turn left at that intersection (with traffic light). In a bit less than a mile, cross Egg Harbor Road and see the school on your right.

Voorhees: Vogelson Regional Library: Driving south on 30, turn left onto Somerdale Road, just above the Echelon Mall. Go under the train bridge in about a half mile, then turn right onto Burnt Mill. Soon turn left onto Laurel Road. The library is on your right. Burnt Mill Road also crosses 544 (Evesham Road) north of the library and White Horse Road (an extension of Springdale) south of it. If you know where the Echelon Mall is, you're home!

UPDATE ON CLEAN ELECTIONS

Speaker Roberts, a leading proponent for New Jersey's Clean Elections model of public financing and the person in a leadership position to make it happen in the legislature, has called "a time-out." Advocates are disappointed since this means there will be no public financing in the 2009 legislative races. The first bump in the road was when the bill (A.100) was pulled in June from the Assembly voting list. Although well organized opponents take credit for that, there was concern voiced by legislative supporters about several provisions. Over the summer the League and other advocates met with sponsors of A.100 and members of the ad-hoc committee charged with drafting the 2009 Clean Elections program.

The second bump was a mid July ruling by the US Supreme Court that found the relaxing of contributions limits for federal candidates facing a self-financed millionaire candidate to be unconstitutional. Although this was not a public financing case, it was used by opponents to question the rescue money provisions of Clean Elections. Rescue money is additional funding (capped at a set amount) given to a publicly financed candidate who faces spending in excess of the Clean Election grant by an opponent or third party.

The third bump was late August when a U.S. District Judge in Arizona singled out Arizona's rescue funds for review. Arizona has had a Clean Election model for all statewide offices for four election cycles.

The opponents of public financing are well financed nationally and providing support to opponents at the state level. They would particularly like to see NJ and CT fail as both were enacted by law rather than citizen initiative.

Ballot questions

There will be two statewide ballot questions this fall.

- One requires that voters approve "new laws that allow the State to borrow money by issuing bonds through any State agency or independent authority backed by a pledge of an annual appropriation to pay the principal and interest on the bonds." Currently most state authorities can issue bonds without voter approval.
- The other removes the appointment process for certain judges from the constitution, thus allowing the legislature to determine how they should be appointed.

Watch for an analysis in the NJ Voter. Both are complicated, and the LWVNJ will not be taking a pro or con position on either of them (at least at this time).
