## Getting there - Directions!

**Bellmawr: James Mullen Community Center**, 29 E. Browning Rd, Bellmawr. Take 295 to 168 South. Browning is in about 0.4 miles. Turn left. In about a block, the building is on the left. *The 400 bus runs up and down Route 168 from Turnersville hourly or more often evenings.*

**Camden County Courthouse**: Take 676 north to Mickle Blvd. Flow right at the fork (don't go on Campbell Place), then turn right onto 5th street in a few blocks. The courthouse is at 5th and Federal, a block up from Mickle.

**Camden, Federal Courthouse**: 4th and Cooper, but we generally car pool. Call 856-795-7878 if you're interested. *About 3-4 blocks from the City Hall PATCO station.*

**Voorhees: Vogelson Regional Library**: Driving south on 30, turn left onto Somerdale Road (gas station with red horizontal stripes on your left, Cunningham's Cleaners on the right), just above the Echelon Mall. Go under the train bridge in about a half mile, then turn right onto Burnt Mill (at the light). Soon turn left onto Laurel Road at a light. (There is a kind of small park with grass and trees on your left just before the turn and a flower-decorated median on Laurel itself). The library is on your right as you pass the mall. Burnt Mill Road also crosses 544 (Evesham Road) north of the library and White Horse Road (an extension of Springdale) south of it. If you know where the Echelon Mall is, you're home!

## Freeholder Meetings

After former President Pearl Friedman suggested at the Annual Meeting that we should go back to observing Freeholder meetings and caucuses, an interesting discussion ensued. The main reason we stopped going is the lack of significant discussion or decision-making at many of them. A few years ago some members went to caucus sessions, and found that even in those "work sessions" very little real debate and discussion took place. At the regular meetings there is even less -- in general, as much time is spent giving out awards and making statements as on the business of the board, almost all of which is adopted unanimously (or unanimously with a few abstentions).

But our guest, former Freeholder Cream, emphatically asserted the value of going to Freeholder meetings. Just being *\*visible\** is critical, she said. And we can always ask questions to show we are paying attention. League members have to be careful not to make statements that may seem to imply League positions, but we can be attentive and ask questions!

So perhaps it is time to reinstate our observer corps, or at least make more of an effort to attend. I will go back to putting the day and time of Freeholder meetings in the Voter. ## Anti-poverty meeting report 6-30-2011

Several members of the LWVCC participated in a planning session for a fall meeting on efforts to combat poverty. *Barbara Sielaff* took some note from the meeting. Here are a few highlights:

In addition to Barbara, Anne Simonoff and Janet Morrison of our League were also present. Amelia Kressler, an LWNJ Member at Large from Gloucester County, was interested in helping (but unable to be present) as well. So the League was well-represented!

Tentative location for the main meeting: Rohrer campus of Camden County College, on Rte 70 in Cherry Hill.

Tentative date(s): Wednesday Oct 5, Tuesday October 11, or Thursday October 13.

Likely time: 7-9 pm.

The focus will be on organizations in Camden, Cumberland, and Gloucester Counties.

A moderator, ideally someone who is well known and would be a draw, is being sought.

Tentative format:

Q & A structured by people putting questions on 3x5 cards; we will screen and present them to the discussants. We want to make sure we have enough time for this, for mingling and talking over coffee at the end, and for people to gather handouts, info about election etc.

At a minimum, people will leave with information they can use to educate their legislators and candidates for office in November 2011 election, and fact sheet to take away. We will get people's names and contact information for future action against poverty. We may hold subsequent meetings to organize groups to work on issues related to poverty.

Possible discussants after Anti-Poverty Network presentation, or sources for experts:

New Jersey Regional Coalition (Housing)  
Tom Knocke, on health care (or homelessness or hunger)  
Carol Wolff of AHEC on health,  
Kevin Walsh on housing

Anyone who has ideas or would like to participate is welcome to join the planning group. Contact Barbara in our League (She's in the directory and her email is [bsielaff@snip.net](mailto:bsielaff@snip.net)), or call the League line at (856) 795-7878.

This could be a powerful meeting to educate the public, and to show them that the League does more than register voters!
