## Getting there - Directions!

**Haddon Township: Rohrer Library:** Take 295 to Route 30 north. On 30, pass King's Highway. In about a mile after King's Highway, just after Nicholson Road on the left, you'll see Cuthbert Road on the right. Turn right onto Cuthbert from 30. Stay on Cuthbert for about half a mile. Just past Hopkins, turn right onto MacArthur. The library is at that corner. // This is the same Cuthbert Road that becomes Cuthbert Blvd further north at routes 70 and 38, so you could take it south from there. MacArthur is about 0.8 miles south of Haddon Avenue on Cuthbert Blvd.

**Voorhees: Vogelson Regional Library:** Driving south on 30, turn left onto Somerdale Road just above the Voorhees Town Center. Go under the train bridge in about a half mile, then turn right onto Burnt Mill (at the light). Soon turn left onto Laurel Road at a light. The library is on your right as you pass the mall.

## **LWVNJ Testimony**

### **Senate State Government, Wagering, Tourism & Historic Preservation Committee January 30, 2014 S.536 Early Voting for Certain Elections**

The League of Women Voters of New Jersey supports S 536. Voting is a fundamental right of citizens. Increasing accessibility to the electoral process is integral to ensuring a representative electorate and the right of every citizen to vote.

As of this date, 32 states and the District of Columbia already have early voting in place. It is time for New Jersey to join them by providing its citizens with accessible early voting.

The League of Women Voters of the United States has identified four priorities for increasing accessibility for voters

- Secure Online Voter Registration;
- Permanent and Portable Statewide Voter Registration ;
- Expanded Early Voting; and
- Improved Polling Place Management

S.536 addresses one of these priorities – it expands the opportunity of citizens to vote by providing, in the 15 days before the general election, early voting opportunities at 3-7 sites within a voter's county and outside of traditional business hours including on the weekends.

Ample research supports early in person voting. The League of Women Voters of New Jersey is in agreement with the findings of the Brennan Center for Justice in the report "Early Voting: What Works." The Brennan Center's research indicates that there are 5 key benefits of early in person voting: reduced stress on the voting system on Election Day, shorter lines on Election Day, improved poll worker performance, early identification and corrections of registration errors and voting system glitches, and greater access to voting and increased voter satisfaction.

Additionally, the Presidential Commission on Election Administration, charged with identifying best practices in election administration and making recommendations to improve the voting experience, includes expanding in person early voting opportunities as a key recommendation in its report.

The League of Women Voters of New Jersey asks this committee to release S.536 as a first step in providing New Jersey voters with increased opportunities to cast their ballot. We thank you for this opportunity to testify and welcome the opportunity to work with you on legislation that addresses our other voting priorities.
